### Methods and material for containment and cleaning up

### Precautions for safe handling

#### Protective measures

#### Advice on general occupational hygiene

#### Conditions for safe storage

Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. ### Hand protection

Wear protective gloves if prolonged or repeated contact is likely. Wear chemical resistant gloves. Recommended: Nitrile gloves.
